



# TERMS & CONDITIONS

## 1. Scope of Work

All services provided by Siranda B. Designs will be outlined in a written proposal or invoice. This may include, but is not limited to: website development, updates, revisions, domain and hosting, and logo creation, . Any additional work outside the original scope may incur extra charges.

## 2. Client Responsibilities

Clients agree to provide all necessary content (text, images, logos, etc.), feedback, and approvals in a timely manner. Delays in providing materials may affect the timeline.

## 3. Payment Terms

A 50% non-refundable deposit of the website development price is required to begin work.

The remaining 50% of the website development price is due upon project completion and before website handoff or publishing. Hosring and Domain charges are due at the completion of the service.

Late payments may incur a fee of 5% per 14 days past due.

## 4. Revisions

Each package includes 3 months of revisions (outlined in the package details). Additional revisions beyond this will be billed according to website update hourly charges.

## 5. Timelines

Typical project timelines range from 1–3 months depending on scope and responsiveness. Siranda B. Designs is not responsible for delays caused by client inaction. Timelines are not set and may go over the allotted timeline.

## 6. Domain & Hosting

Clients are responsible for purchasing a domain and hosting plan—either independently through a third-party provider or through Siranda B. Designs, who facilitates setup via a third-party host.

Siranda B. Designs is not responsible for any issues, outages, or fluctuating charges related to third-party providers. Clients are encouraged to review and understand the pricing and terms of the third-party host prior to purchase.

## 7. Ownership & Copyright

All website designs, layouts, and visual assets created by Siranda B. Designs remain the intellectual property of Siranda B. Designs by default. Upon final payment, clients are granted a limited license to use the completed website for their business.

If full ownership of the site is requested, a Site Ownership Transfer can be completed for an additional one-time fee of \$150. Upon transfer, the client assumes full responsibility for the site and its ongoing maintenance, billing, and management.

Clients may not replicate, redistribute, or resell the website without written permission unless ownership has been officially transferred.

## 8. Cancellations & Refunds

Due to the nature of design work, deposits are non-refundable. If the client cancels the project after work has begun, they are responsible for payment for the work completed up to that point.

## 9. Support & Maintenance

Each project includes 3 months of post-launch support. After this period, updates or maintenance can be provided at an additional charge or under a separate maintenance plan.

## 10. Legal
